#### **DESCRIPTION**

This VMS License Management Facility allows the system manager to easily determine which software products are licensed on a standalone VAX and on each of the VAX systems in a VAXcluster System. It allows the system manager to select the subset of systems or users in a VAXcluster that may use the software products. LMF also provides an audit trail which allows the system manager to track license changes that occur within a VAXcluster system.

V5.x VAXcluster configurations are fully described in the VAXcluster Software Product Description (29.78.xx) and include CI, Ethernet and Mixed Interconnect configurations.
